MESSAGE FROM THE TOURNAMENT CHAIRMAN



As I write this, I think back to that day in November when, after meeting with Ann, I gathered up all the material that goes with this job, left the office in Manhattan and headed for my home on Long Island to see what the next two years had in

store for me. For several days I pored frantically through a five pound procedure book (yes, I weighed it), and two boxes of files, folders and papers. My family began to approach me warily, much as one approaches a person who is in desperate need of custodial care. I am glad to tell you that with Ann's help and encouragement, and the gentle concern of those closest to me, I have come back from the brink.

If you have looked at the January issue of TEE TALK, you know that we have outstanding courses for our tournaments this year: the Match Play at Montclair, the Stroke Play at The Creek, Seniors A at Plainfield, Husband/Wife A at Piping Rock, the Shore B at Navesink and Shore Oaks, to name a few. Do venture out of your districts; there are bridges and tunnels that will bring you to marvelous courses.

Now that you are eagerly looking forward to signing up for tournaments in all three districts, let me give you a few do's and don'ts to remember when filling out the tournament entry cards:

DO fill in the name and site of the tournament.

DO fill in the date of the tournament in space provided.

DO stamp and self-address the card.

DO include your current USGA Handicap Index.

DO send a check with entry if there is a tournament fee.

DONT mail the card to arrive before the opening date for entries. It will be returned.

DONT send in one check for two or more tournaments. Thanks for your cooperation.

This year we will be using the USGA's recommended method of matching cards to decide ties in stroke play competitions. As usual, there will be a play-off in all ties for trophies. All other ties will be determined on the basis of the best score for the last nine holes. If the tying players have the same score for the last nine holes, the winner will be determined on the basis of the last six holes, last three holes and finally the 18th hole. If this procedure does not produce a winner, there will be a draw of cards.

I want to express my appreciation to the Met Reps who helped us secure dates at their clubs for the 1991 season. In the WMGA Constitution, the Met Rep is defined as a Member of a Member Club who has been appointed or elected by that club to represent it in such business as may be transacted at a meeting of the Association. That definition doesn't begin to cover all that the Met Rep does for the organization. Each year she is called on to help the Membership and Team Match committees. In years when her club has been selected to host a tournament, she is asked to have the date confirmed and to assist the district tournament chairman with arrangements for the event. Thanks Met Reps!

I am looking forward to the 1991 season and hope you are too. Have a wonderful year playing that extraordinary game we all love.
